

## IFDS brings in-house the Production and Distribution of Customer Statements with GMC Software

After reviewing all its existing print production facilities, the business identified the need to streamline document production and composition to reduce costs and offer clients more flexibility.

IFDS needed a system which could manage all aspects of the production workflow: a system that caters for complex data processing and integrates mailsort and print file generation – wherever that might be.

### **Systems and Service**

IFDS is a joint venture between DST Systems and State Street. Similar joint ventures operate in Canada, Ireland, Luxembourg and the USA. Everyday IFDS' software handles over 17 million investor accounts worldwide, with over 150 clients.

Globally, IFDS' services are used by retail and institutional fund managers, fund distributors and platforms, investment trust companies, and providers of group and individual defined contribution pensions.

Its aim is to be the industry benchmark for client satisfaction, building long-term partnerships by not only consistently meeting its commitments, but exceeding client expectations. Clients are invited to use IFDS' services and technology in a way that best suits their business and as customer requirements evolve, it is important for IFDS that it retains the flexibility to change with them.

### **The issues**

After pre-processing the data, the print was outsourced to external print providers. However, customer feedback showed that this system did not provide the service levels and turnaround times that IFDS wanted and customers had come to expect. There was also room for improvement in the design process with functions such as merging multiple data sources into a single envelope, gathering data from external data bases, dynamic marketing messaging, version control, data manipulation and design complexity.

To tackle these issues, IFDS decided to bring around 50% of its bulk print and mail operation in house and scan the market for better composition tools.

- introduce uniform output.

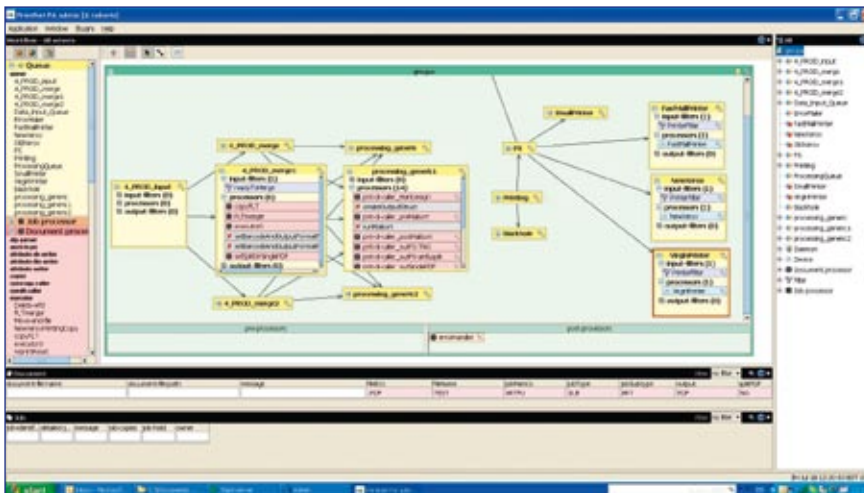
